Sir/Madam,

I am directed to refer to this office letter of even number dated 10.9.2012 on the subject mentioned above. The Governing Council of ICMR has approved the amendments to the Rule 7(iii)(k), Rule 12(g) and Rule 14 (Power to relax of Health Research Scientist Cadre (HRSC) of ICMR to the extent as given below:-

S.NO	Rule	Existing Provision	Revised Provision
1	Rule 7 (iii) (k)	On regular appointment in the cadre, of a scientist in continuation of contract appointment, the period of service rendered in contract capacity in the grade shall count towards residency period for assessment/promotion provided that the officer is selected for regular appointment at the first attempt However, his seniority shall be fixed as per guidelines laid down by the Department of Personnel & Training.	Deleted *
2	Rule 12 (g)	The benefit of added years of service as admissible under Rule 30 of CCS (Pension) Rules, 1972, as amended from time to time shall be applicable to the eligible members of service.	Deleted**

Rule 14
(Power to
relax)

Where the Government is of the opinion that it is necessary so to do, it may, by order, for reasons to be recorded in writing, relax any of the provisions of these rules in respect of any class or category of persons.

Where the Director General, ICMR is of the opinion that it is necessary so to do, it may, by order, for reasons to be recorded in writing, relax any of the provisions of these rules in respect of any class or category of persons.

* However, the method of recruitment on contract as provided under Rule - 5(d) will remain operative.
