
ADDENDUM

2. The Educational Qualification - (i) experience for Scientist-F post shall be M.Sc First Class with 12 years experience instead of 10 years experience
3. The managerial experience, inadvertently omitted, prescribed for scientists-D,E & F posts is being restored (as in original) as follows under schedule-III :

Scientists-D – Out of which 2 years in a managerial position to handle R&D projects in a team effectively in a directing capacity.

Scientists-E & F – Out of which 3 years in a managerial position to handle R&D projects in a team effectively in a directing capacity.
